#### PARKING/ENTRANCES: 8415 BELLONA LANE SUITE 114

## **CLOSEST ENTRANCE:**

- Turn right into building entrance.
- Drive around to back (East Side) of building.
- Entrance is unmarked black door, 5 windows down from South end of building.
- Enter, then go through second black door marked "First Floor Offices".
- Suite 114 is first suite to your right.

## **PROFESSIONAL ENTRANCE:**

- Turn right into building entrance.
- Parking area is to your right (South side).
- Enter at professional entrance (second floor) and take elevator or stairs to first floor.
- Elevator is half-way down corridor on left. Take down to first floor lobby and proceed to Suite 114.
- Stairs to first floor are through unmarked white door at first green exit sign on right.

## LOBBY ENTRANCE:

- Park on street out front.
- Enter through lobby (first floor).
- Take corridor to right and proceed to Suite 114 on left.

# DIRECTIONS TO 8415 BELLONA LANE (RUXTON TOWERS) SUITE 114

#### **GENERAL DIRECTIONS:**

- Having just turned onto Bellona Avenue (heading West)
- Turn immediately right onto Bellona Lane
- Ruxton Towers is 10 story building on right

#### FROM NORTH:

- Take I-83 South until it forks into I-695
- At fork, take left ramp: "695 East to Towson"
- East ramp divides in two

- Take right half of East ramp: "Charles Street (Route 139)"
- Merge onto Charles Street South
- Take first right onto Bellona Avenue (heading West)
- See general directions above

## **FROM SOUTH:**

- Take Charles Street North
- Pass through first intersection with Bellona
- At second Bellona intersection (Kenilworth on right)
- Turn left onto Bellona Avenue (heading West)
- See general directions above

## **FROM WEST:**

- Take I-695 East toward Towson
- Take Exit 25: "Charles Street (Route 139)"
- Get in right lane and merge onto Charles Street South
- Take first right onto Bellona Avenue (heading West)
- See general directions above

#### FROM EAST:

- Take I-695 West toward Towson
- Take Exit 25: "Charles Street (Route 139)"
- Turn left onto Bellona Avenue and go around circle
- Merge onto Charles Street South
- Turn right at 2nd light onto Bellona Avenue (heading West)
- See general directions above
